- c) André Afonso Fernandes, student number 93011, does not fulfill the eligibility condition enshrined in point iv, paragraph 1, of the Third Article of the Regulation, that is, the per capita income higher than the index value;
- d) Ângelo Mpingafana Domingos Joaquim, student number 95475, does not fulfill the eligibility condition enshrined in point 3, of the Third Article of the Regulation, regarding the submission of all documents:
- e) Cíntia Sousa Gomes, student number 95744, does not fulfill the eligibility condition enshrined in point ix, of paragraph 1, of the Third Article of the Regulation, regarding the fact of enjoying another scholarship higher than the tuition fee;
- f) Daniel do Couto Vilão, student number 98731, does not fulfill the eligibility condition enshrined in point iv, of paragraph 1, of the Third Article of the Regulation, that is, the per capita income higher than the index value;
- g) Gonçalo Filipe Marques Fernando, student number 93923, does not fulfill the eligibility condition enshrined in point i, of paragraph 1, of the Third Article of the Regulation, regarding enrollment in the academic year 2020/2021;
- h) Hernâni Lucas Carvalho do Amaral, student number 93775, does not fulfill the eligibility condition enshrined in point ix, number 1, of the Third Article of the Regulation, regarding the fact of enjoying another scholarship higher than the tuition fee;

- i) Hugo Caumo, student number 88012, does not fulfill the eligibility condition enshrined in point iii, paragraph 1, of the Third Article of the Regulation, regarding academic performance;
- j) José Carlos Furtado da Veiga, student number 88120, does not fulfill the eligibility condition enshrined in point ix, paragraph 1, of the Third Article of the Regulation, regarding the fact of enjoying another scholarship higher than the tuition fee;
- k) Mário Anderson dos Santos Gomes, student number 91124, does not fulfill the eligibility condition enshrined in point iii, paragraph 1, of the Third Article of the Regulation, regarding academic performance;
- I) Miguel Cardoso Valério, student number 86483, does not fulfill the eligibility condition enshrined in point iv, of paragraph 1, of the Third Article of the Regulation, that is, the per capita income above the index value;
- m) Miriam Oliveira Lima, student number 97438, does not fulfill the eligibility condition enshrined in point iii, paragraph 1, of the Third Article of the Regulation, regarding academic performance;
- n) Nuno Miguel Gonçalves Pereira Matos Martins, student number 99292, does not fulfill the eligibility condition enshrined in point ix, of paragraph 1, of the Third Article of the Regulation, regarding the fact of enjoying another scholarship higher than the tuition fee;
- o) Rafael Gaspar Ferreira, student number 97343, does not fulfill the eligibility condition enshrined in point ix, of paragraph 1, of the Third Article of the Regulation, regarding the fact of enjoying another scholarship higher than the tuition fee;
- p) Sérgio Fonseca dos Santos, student number 97138, does not fulfill the eligibility condition enshrined in point ix, of paragraph 1, of the Third Article of the Regulation, regarding the fact of enjoying another scholarship higher than the tuition fee;
- q) Silvestre José Rodrigues Pires Alves, student number 85349, does not fulfill the eligibility condition enshrined in point iii, paragraph 1 of Article 3 of the Regulation, regarding academic achievement;
